Tonight's Music:



2002	Project Home becomes HomeShare Vermont & the Polly Rowe Memorial Fund is created
2003	HomeShare Vermont expands into Grand Isle County
2005	HomeShare Vermont becomes an independent non-profit corporation
2006	HomeShare Vermont expands into Addison County & hosts National Shared Housing Conference
2007	Capital Campaign is completed & our new office in South Burlington is purchased
2010	The HomeShare Vermont Fund is opened at the Vermont Community Foundation

Thank You Cathedral Square!

We would not be here today celebrating our 40th anniversary if it were not for Cathedral Square Corporation (CSC). While the Retired Senior Volunteer Program (RSVP) gave birth to HomeShare Vermont, it was Cathedral Square Corporation who nurtured and raised us into adulthood. In 1984, Cathedral Square Corporation reached out and took HomeShare Vermont (then Project HOME) under their wings and "adopted us" when we outgrew the sponsorship of RSVP.



Cathedral Square provided a home for HomeShare Vermont rent free for 15 years in their flagship building at 3 Cathedral Square in Burlington. They also became the fiscal administrator, keeping the finances on track and helping to provide needed cash flow for this small organization, free of charge. "They provided support as we needed it, but also gave us the autonomy to develop our program and services as we saw fit," said Helen Head, a former Executive Director of HomeShare. "They couldn't have been more supportive."

Sarah Carpenter was the Executive Director of Cathedral Square Corporation when approached to be our sponsor. "They were trying to serve the same elder population and we had many folks who we could not serve in our apartments and others who did not want to move out of their homes but needed some help. It was a natural fit," Sarah said.

In 2005, after several years of discussion and planning, Homeshare Vermont ventured out on our own and became an independent non-profit corporation. We continue to work very closely with Cathedral Square, including in the creation of our new home in South Burlington. In 2007, again with the support of CSC and then Executive Director Nancy Eldridge, along with Amy Wright, we purchased our new office space as a condominium and again co-located with Cathedral Square. They still provide us with bookkeeping services!

Media Sponsor: The Media Factory

Vermont Community Access Media (VCAM) and the Regional Educational Television Network (RETN) – now merged into the Media Factory – co-located in 2007 at 208 Flynn Avenue in Burlington's South End. During that time RETN and VCAM together successfully built a state-of -the-art media education classroom, a low power FM radio station (99.3 WBTV-LP), a new server room in partnership with CCTV/Town Meeting Television to house all of the technical



channel operations and rebranded the shared facility as the Media Factory.

In 2018, the VCAM and RETN boards entered a joint strategic planning process and assessment of community needs. The resulting plan called for RETN and VCAM to officially combine forces as the Media Factory to create a vibrant, 21st century community media center - ensuring that the Media Factory remains an essential community resource well into the future. The Media Factory merger was made official in April 2021.

The Media Factory is a community of media makers who work in tv, film, radio, and more. The Media Factory provides the tools, training, space and access to distribution that give you the power to share your story.


