We also rely on fees from people who participate in our program. Our fees only cover a portion of the actual costs of our services.

Match Fee: Payable at the time the match agreement is signed.

The match fee only applies to customers for whom we are successful in finding a compatible match and is due when the match agreement is signed. The match fee is based on a sliding scale according to gross annual income. We will provide you a bill when your match fee is due.

All fees are non-refundable. If your match should end unexpectedly within the first three months, your paid match fee will be credited in full toward your next match.
